

# **BikeErg Sprints 2026 Giveaway Rules**

## **Clubs can win a BikeErg®**

The 2026 BikeErg® Sprints takes place between July 8-12, 2026. Clubs or teams of at least ten participants will be eligible for the chance to win a BikeErg® (valued at \$1100, the “Prize”), which will be shipped to one winner free of charge. To be eligible to win, clubs must timely submit 10 or more results from a BikeErg® Sprint event held at their facility during the event, as set out below. Winner will be selected in a random drawing and one Prize will be awarded and shipped to one eligible winner.

## **How to enter**

To be eligible for the drawing, clubs or teams must send their team member names, dates of birth, and race results by email to [info@concept2.com](mailto:info@concept2.com) no later than July 13, 5:00 pm ET. Eligible entrants must use the BikeErg® Sprints Event Entry Form for their submission. Late submissions cannot be accepted. All results MUST be submitted by July 13, 2026 5:00 pm ET to be eligible to win.

## **Eligibility**

Open to clubs or teams in 49 of the 50 United States (Rhode Island excluded) and D.C. Team members of the BikeErg Sprints may include Concept2, Inc. (“Concept2”) employees or their household members if they are a team or club member of the entrant. Residents outside the United States are not eligible to enter or win. Limit one entry per club or team.

## **Drawing**

A random drawing will be conducted on or about July 15, 2026 by Concept2 to select the winner from among all eligible entries received. Odds of winning depend on the number of entries received.

## **How winner will be notified**

The Prize winner will be notified via email on or before July 16, 2026 at 11:59 ET. If a winner is ineligible or unable to accept the prize awarded, a new winner will be selected from all eligible entries. Prize will be delivered by FedEx at Concept2’s expense within the U.S.
